COATS FOR KIDS - JLA WORKED WITH AUSTIN INDEPENDENT SCHOOL DISTRICT (ISD), DEL VALLE ISD, PFLUGERVILLE ISD, AND CHARTER SCHOOLS TO RECEIVE COAT ORDERS IN ADVANCE, AND CFK VOLUNTEERS SELECTED AND PACKED 13,906 INDIVIDUAL ORDERS RECEIVED FROM THOSE 162 SCHOOLS. CFK THEN DISTRIBUTED AN ADDITIONAL 15,502 COATS TO 50 COMMUNITY ORGANIZATIONS AND NONPROFITS THROUGHOUT CENTRAL TEXAS, INCLUDING 239 COATS DISTRIBUTED AT THE H-E-B FEAST OF CARING EVENT AT PALMER EVENTS CENTER.
